HQ2 TO DC, MD OR VA? Experts Say Region is Bezos' Top Choice

More signs are beginning to indicate that a site in the Washington DC region will be selected for the much anticipated second headquarters for Amazon. A decision of this magnitude will impact everyone in the region as it will bring 50,000 jobs, provide a surge in income tax revenue, and spur significant real estate development.

Of course, it also comes with a fair share of headaches as well. Increased stress on transportation infrastructure, a shock to home values perhaps further exacerbating the urban housing affordability crisis, and highly controversial corporate incentives are a part of the deal.

OPEN DC HOSTS FIRST EVENT OF THE YEAR Business Tax Law Update with G.F. Joey Musmar

OPEN DC hosted Joey Musmar, CPA, CFF, CVA, who gave an insightful and opportune presentation on updates to business tax laws. Given the legislative whirlwind in congress over the past 12 months, many business owners have been left wondering how the most recent regulatory changes will impact them. Congress approved the Tax Cuts and Jobs Act (TCJA) on December 22, 2017 and although many in the accounting field are able to digest the updates, the sophisticated nature of tax and accounting laws can sometimes disorient even experienced small business owners.

Joey Musmar, a Partner at Miller Musmar based in Reston, Virginia, educated the audience on the impact changes can have based on the firm's revenue, legal entity, and even the structure or presence of local vs international ownership. The attendees were also briefed on expenses that were removed from the current permissible deductions write-off list. The audience's interest piqued during a discussion on the impact that a transition from an S Corporation to a C Corporation would have on retirement planning. As the old adage goes, there are two guarantees in life, death and taxes.

How do you handle the anxiety and challenges of a start up?

If one picks ideas that are close to one's heart but at the same time based on real market opportunities, then the ride itself becomes exciting despite challenges and the potential of failure. Also, myopic inside-the-box thinking in difficult times increases anxiety, so I have always invested time in activities or interests beyond business to unwind and to get fresh ideas that can sometimes help in overcoming those challenges.

As a busy entrepreneur, what does your typical day look like?

The morning half of my day is typically structured with meetings and conference calls. But the afternoons and evenings are more flexible where I focus on more strategic issues. I believe that being too

So why exactly do economists, politicians, and business leaders feel that Amazon is leaning towards the DC region? Well for one thing, Amazon founder Jeff Bezos loves the area. He owns The Washington Post and purchased a second home for a whopping \$27 million. Amazon Web Services already has a significant presence in Northern Virginia and the region posseses three airports, top-notch educational institutions, high quality of life, and provides immediate access to the power structure of our government.

Oddsmakers have named Atlanta and Boston as the frontrunners. Given Amazon's progressive corporate culture, Atlanta's chances may have taken a hit after Georgia's legislature removed a tax-exemption for Delta Airlines after its squabble with the National Rifle Association. Boston is running into issues with the availability of contiguous developable land and Amazon recently took an additional 1 million square feet of space not tied to HQ2. Baltimore is the only major east coast city that was exempt from the list after Amazon had narrowed it down to 20. Officials have cited the lack of available tech talent the driver behind the decision.

The sites pitched in Virginia are Crystal City, Rosslyn, and the Center for Innovative

What is one achievement that you are most proud of?

Over the last two decades, Techlogix hired more than 1,500 engineers in Pakistan. Nearly a dozen software companies operating successfully in Pakistan and abroad have been formed by our ex-employees, so we have been quite a nursery for polishing engineering talent and sowing further seeds of entrepreneurship.

What in your opinion is the critical factor that made you successful?

Over the longer term, the critical factor has been flexibility of strategy – the capability to innovate every few years so that the company moves in a new exciting dimension and does not become stale.

Technology in Herndon. DC Mayor Muriel Bowser proposed four sites including NoMa, Shaw, Hill East and along the Anacostia River. Maryland Governor Larry Hogan has pitched the former White Flint Mall site as the best option.

What's my guess? South Lake Union, where Amazon's main headquarters is, was a patchwork of parking lots, warehouses, and low-rise industrial buildings before Amazon's transformed it. Sounds like a place I know. Anacostia.

What is one failure you had as an entrepreneur, and how did you overcome it?

We have been a profitable company for most of our existence but several years ago, we expanded operations so rapidly in many countries that our expenses went out of whack and we suffered substantial losses. It took us 3 years to come out of the red but we re-established profitability by revamping our project control processes and being more selective in geographies to operate. Importantly, we overcame our predicament without laying off a single employee in those tough times.

What would be your advice for the new entrepreneurs?

Do a lot of soul-searching first to make sure that you are launching on this journey with full conviction and not because entrepreneurship is such a fad these days. Once past this filter, bet hard on your instincts and do not give up easily at the first few hurdles or criticism that you face.

Tip for readers

Balance and stability in personal life brings happiness and satisfaction. Marketplace rewards has limited shelf life. As an entrepreneur one must maintain a healthy balance between passion and family life.

What made you decide to become an entrepreneur?

I was a Mechanical Engineer working in product development in telecom industry. After working in the industry for 15 years, I was somewhat frustrated with my career and work practices. I wanted more control of it. That led me to look for jobs in startups where one can define the work environment and practices.

How do you handle the anxiety and challenges of a start up?

As a father of three school going children, the anxiety I had was the market acceptance of the product we were developing, which would translate into company success.

In the pre-internet and telecommuting era of the 1990's the biggest challenge was to deal with the unstructured environment of the start-up. On a daily basis your role could evolve from janitor to media relations officer (accordingly you would keep different sets of clothes in office to dress according to the needs of the hour). Agility was the other challenge, as we were in unchartered territory, had to constantly change direction and adjust to cross winds.

As a busy entrepreneur, what does your typical day look like?

One of my principle was not to bring work home. I would start early in the morning, so that I can be home before my children would go to bed. The month of Ramadhan was very productive, as I could start earlier in the morning. My most productive time was before normal work day would start, when interruptions from door knocking and phone ringing would start. We had an open-door policy, that helped in many ways, but created extra work for decision makers.

Time management was essential, I had allocated a good portion of single day for staff meetings; similarly portion of one day for external meetings – customer, vendors, etc.; portion of one day on marketing and product development issues; portion of one day on administrative issues. This made my work environment structured for most of work week.

What is one achievement that you are most proud of?

When our first product was shipped to customer. We achieved this by shrinking

product development time in half, through risk taking, smart working and workflow. Another proud moment was when we hit \$1 billion in revenue, within less than eighteen months of our first revenue dollar.

This led to our company going Public in February 1997 and hit a market cap of \$1.9 billion on the first day of trading on NASDAQ stock market

What in your opinion is the critical factor that made you successful?

There are many factors. Maneuvering market conditions, and managing customer requirements, educating customers what is good for them. Staying ahead of technology developments and trends. Attracting good talent and maximizing employee satisfaction.

What is one failure you had as an entrepreneur, and how did you overcome it?

With success come arrogance. We were convinced that we could do nothing wrong. Till one day one of our major customer decided not to renew their purchase order because of their business needs. The news was released after close of stock market. Next morning at stock market open we lost half of our company value. That evening and night we were all looking for ways how to minimize the impact to employees and investors.

Employees understood the rationale of cancellation of order. This introduced some humility amongst employees and the corporate culture. Morale was down for few days but got back to normal level in 3-4 weeks' time.

Investors were not that impressed and took us more than a year to recover the lost value of the company.

What would be your advice for the new entrepreneurs?

There are many. Success will follow you, if you are willing to work hard and smart, take risk, and be agile. It's more challenging to manage success, than to be successful.

Avoid becoming a victim of your success. This could be due to Product/Industry migration. Success brings arrogance, remain vigilant not to let it creep in. You must plan for growth but keep your feet on ground.

OPEN DC held its first mentorship session of the year with Narjis Ali, President of Sure Secure Solutions and a former OPEN DC Chapter President. The sold out event was moderated by Charter Member Mushtaq Khan and Executive Committee Member Habeeb Syed. During the conversation, Narjis shared her background and experience on a wide range of topics which included:

- Guidance on how to enter the government contracting sector.
- Leveraging smaller opportunities to establish a track record and build relationships.
- Developing proposal writing skills.
 Tracking government-wide acquisition contracts.
- Differentiating yourself in a competitive environment through appropriate emphasis on unique skills and digital marketing.



HYPERLOOP ANYONE? The Boring Company is Generating Excitement

Last Fall, Maryland Governor Larry Hogan announced that Elon Musk's "The Boring Company" received approvals from the Maryland Department of Transportation for the East Coast Hyperloop. The underground tunnel would bring a much needed high-speed transit option to the region, allowing for a trip from Baltimore to Washington D.C. in 15 minutes.


The Boring Company website has shared an image (left) of the tunnel's route and reported that construction could be done in 12 to 20 months. The twin tunnels would run parallel to each other and can travel up to 150 miles per hour. Each skate can carry between 8 and 16 passengers and the project is 100% privately funded. Perhaps the most eye opening feature is its human scale and minimally invasive construction. The size of stations will be no larger than a few typical parking spaces and there would be no construction noise to its 30-foot depth.

Who knew transit could be this exciting?
